The Beginning of the War

• "In June 1971, Nixon officially declared a War on Drugs, telling Congress that drug addiction had become "a national emergency" and that drug abuse was now "public enemy number one." Following this announcement, drug use officially became a criminal issue, and Nixon began proposing strict measures for drug-related crimes, including mandatory minimum sentences for both drug possession and distribution" (Pascual 4).

 "In the 1980s, the crack cocaine epidemic began to sweep the nation. Fears of this epidemic prompted newly elected President Ronald Reagan to reinforce and expand many of Nixon's anti-drug policies, arguing that drug use was a "repudiation of everything America is."

Did it Work?

In the last 40 years, the number of people convicted of drug-related crimes has <u>risen more</u> <u>than 500 percent</u>, now making up almost half of the federal prison population. Within America's prisons, the policies have perpetuated cycles of poverty and unemployment in low-income communities while disproportionately impacting people of color"
